



## Hunters and Anglers Want a 2018 Farm Bill That Works Better for Wildlife, Landowners, and Rural America

**A**cross the nation, working private farms and forests provide essential access for America's hunters and anglers, driving a rural outdoor recreation economy worth billions of dollars. The Farm Bill delivers more than \$5 billion annually for conservation on these important private lands, and this funding is fundamental to improving soil health, water quality, and fish and wildlife habitat. In the 2018 Farm Bill, sportsmen and women support maintaining strong funding for Title II conservation programs and the following top priorities for conservation and access:

- 
- **Agricultural Conservation Easement Program (ACEP):** Improve ACEP's ability to meet increasing demand from landowners to conserve farmland, forests, grasslands, and wetlands through easements.
  - **Conservation Compliance:** Retain the linkage between compliance and crop insurance. Strengthen Sodsaver by closing the 'alfalfa loophole' and collecting better data on grasslands loss.
  - **Conservation Reserve Program (CRP):** Increase available acreage in a manner that benefits wildlife and water quality in all regions.
  - **Environmental Quality Incentives Program (EQIP):** Increase portion of EQIP funds that are used for wildlife investments.
  - **Regional Conservation Partnership Program (RCPP):** Enhance the ability of public-private partnerships to scale-up work on regional conservation priorities for water quality, water quantity and wildlife outcomes.
  - **Voluntary Public Access and Habitat Incentive Program (VPA-HIP):** Increase states' abilities to provide recreational access on private lands.
- The mission of the Theodore Roosevelt Conservation Partnership is to guarantee all Americans quality places to hunt and fish by uniting and amplifying the voices of our 56 organizational partners in order to strengthen federal policy and funding.
- TRCP's 24-member Agriculture and Wildlife Working Group, a subset of the larger partnership, works specifically to balance the needs of production agriculture and private landowners with the needs of fish and wildlife, while sustaining and enhancing economically important recreational access to private lands. This work is done primarily around the federal Farm Bill, the single-largest source for private lands conservation funding.

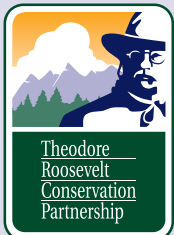
